A total of Twenty (20) bid qualified for price comparison, as it was only seven within the cost estimate. The project cost estimate is at **N\$161,983.00** excluding VAT and bidder who were **within 5% above or below the cost estimate** range of **N\$186,280.45 – N\$137,685.55** were considered being responsive, those who were below and above the cost estimates range were regarded being non-responsive. To determine the most responsive bidder, financial evaluation was conducted with exclusion of VAT to provide a fair assessment for all bidders.
