Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of bidders, the amount quoted, and the presence or absence of a Bid Securing Declaration will be made available to bidders within three working days of the opening.
